*All interested members of the Lodge are also invited to attend.*



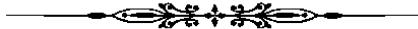

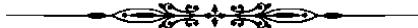

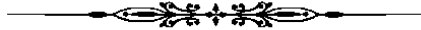
